**SUBJECT:**

Acceptance of the First 5 Stanislaus 2024-2025 Annual Program Evaluation Report

**BACKGROUND:**

Section 130100 of the California Health and Safety Code requires local Commissions to “use outcome-based accountability to determine future expenditures.” This provision of law has been interpreted to require evaluations to be conducted of programs funded with Proposition 10 funds. The First 5 Stanislaus Strategic Plan includes the structure to evaluate its programs in alignment with the State’s results area framework.

For its 2024-2025 Annual Program Evaluation, the Commission uses three result areas for evaluating program outcomes: Improved Family Functioning; Improved Child Development; and Improved Systems of Care.

There were a variety of methodologies used by First 5 Stanislaus staff to review all funded programs. These included annual site visits, data analysis from multiple sources, and the preparation of an annual report.

The 2024-2025 Annual Program Evaluation report is designed to provide Commissioners and the public with important information including: the funding distribution of the various Commission contracts in relation to Result Areas; historic funding levels; geographic distribution of contracted services; demographics of funded program recipients; and outcomes/effectiveness of the contracted programs evaluated by the Commission.

The Administrative and Finance, the Operations, and the Executive Committees were informed of this item at their respective meetings on March 9<sup>th</sup>, March 12<sup>th</sup>, March 18<sup>th</sup>.
